What is Personnel Vetting?

Personnel Vetting: The process by which covered individuals undergo *investigation*, *evaluation*, and *adjudication* of whether they are, and remain over time, suitable or fit for federal employment, eligible to occupy a national security sensitive position, eligible for access to classified information, eligible to serve as a contractor employee, or authorized to be issued a federal credential.

Vetting includes all steps in the end-to-end process, including determining need (appropriate position designation), validating need (existence of a current investigation or adjudication), collecting background information via standard forms, investigating activity, adjudication, providing administrative due process or other procedural rights, and ongoing assessments to ensure individuals continue to meet the applicable standards for the position for which they were favorably adjudicated.

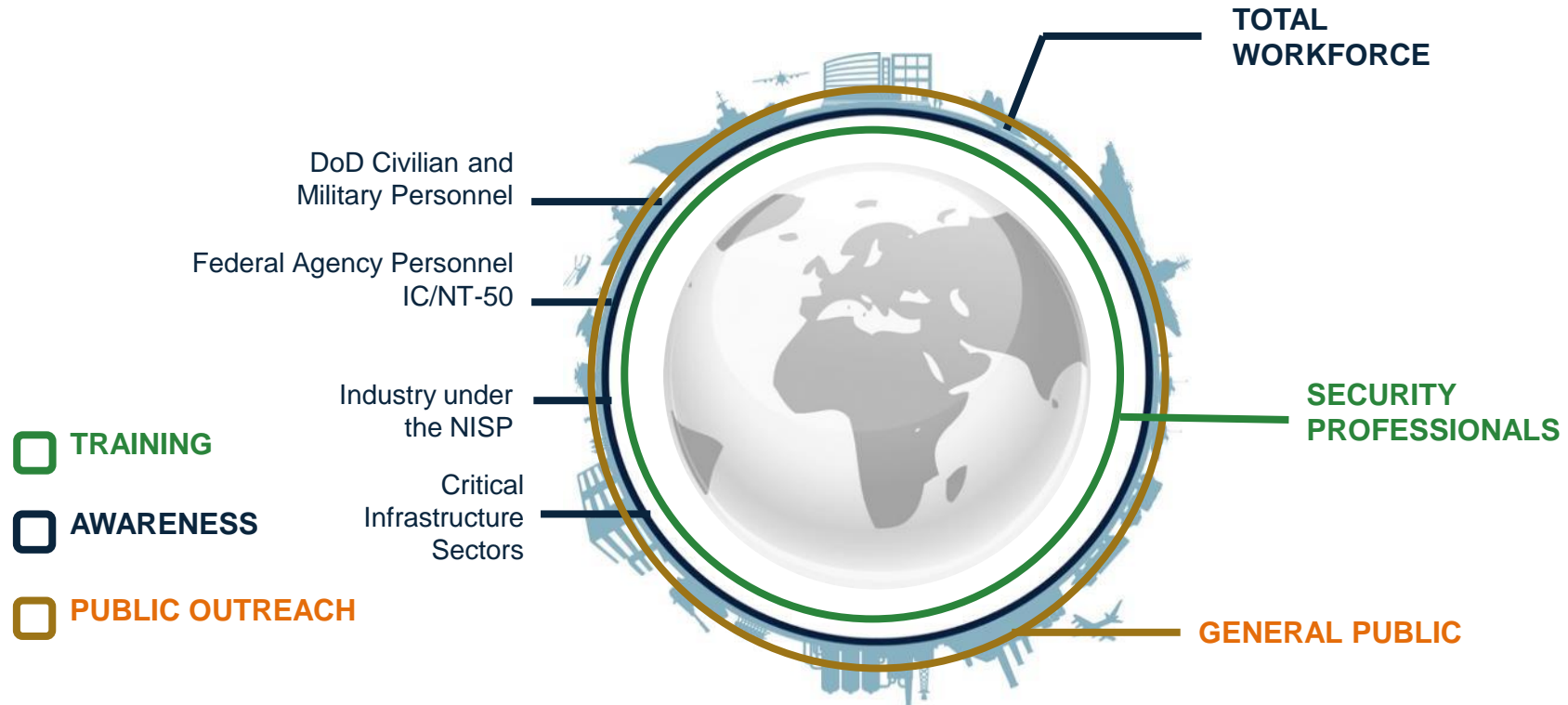

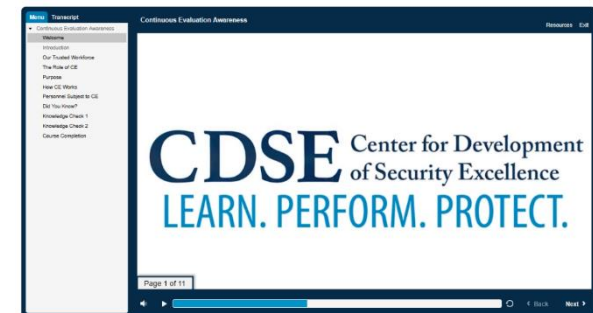

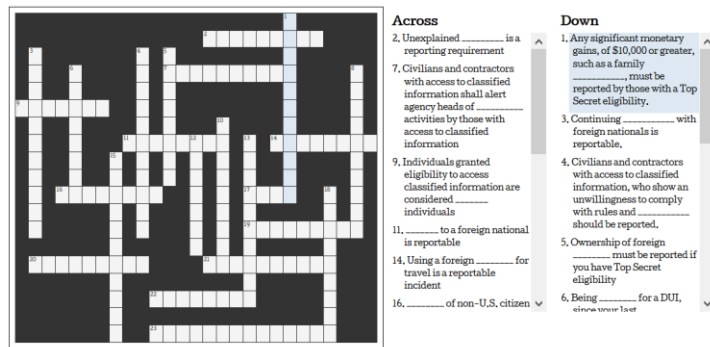
