

How to Add a Category to your PSM Net

6

 **What is a PSM Net?** 

- The Personnel Security Management (PSM) Net concept is based on security relationships with individual person categories instead of Units or Organizations.
- A PSM Net associates a Security Management Office (SMO) with the person categories for whom they have responsibility.



 **PSM Net Purpose** 

The PSM Net allows the Security Managers or FSO in a SMO to:

- Take security actions
- Run reports
- Receive notifications on their personnel

Before Establishing your PSM Net

Establishing and validating your PSM Net is the most important and time-consuming part of JCAVS.

Your PSM Net is essentially a validation list.

Before you begin establishing your PSM Net, it is highly recommended that you start with an accurate listing of all personnel you have security responsibility over.

Owning vs Servicing Relationship

- In order to take action on a person, you must first bring that person's category into your PSM Net in an owning or servicing relationship.

In order to comply with CYBERCOM TASKORD 13-0641, JPAS/SWFT/DCII will be decreasing the inactive account deletion deadline from 90 days to 45. This change will not affect the current 30 day account lock due to inactivity. Users should remember to login every 30 days to prevent any interruption in access. Joint Personnel Adjudication System (JPAS)

ATTENTION ALL JPAS USERS

It is a violation of DoD Regulations to share username/password, any Approved Active Public Key Infrastructure (PKI) Certificate, or allow an individual to access another person's JPAS account in any manner or form. Only the authorized account holder is permitted to access/use his/her account. Examples of Approved Active PKI Certificates are Common Access Cards (CAC) and Personal Identity Verifications (PIV) cards, to include External Certificate Authority (ECA) cards. There are no combined or "company" JPAS user accounts. Users are required to have their own Approved Active PKI Certificate and JPAS account. Individuals cannot use another person's credentials. If you are not using your own account and certificate that are assigned to you, DISCONTINUE USING JPAS IMMEDIATELY and inform your Industrial Security Representative. Any Account Manager, authorized or unauthorized user who violates JPAS security and account management policies will risk immediate forfeiture and TERMINATION of their JPAS account, regardless of any access requirements that may exist to support mission-critical and job-essential tasks. When you select "AGREE" at the bottom of this page, you are agreeing to comply with all JPAS administration policies, to include the forfeiture of JPAS access if terms of use are violated.

DATA YOU ARE ABOUT TO ACCESS COULD POTENTIALLY BE PROTECTED BY THE PRIVACY ACT OF 1974. You must:
