

Federal Personnel Vetting Investigative Standards

Crosswalk Job Aid

Federal personnel vetting (FPV) is divided into three aligned investigative tiers to support trust determinations for all personnel vetting domains: Suitability, Fitness, National Security and Credentialing (HSPD-12).

- 1 Low Tier (LT)** – Investigations conducted to this standard are for positions designated as Non-Sensitive/Low Risk. This is the minimum investigation standard for granting physical and/or logical access, or (HSPD-12) credentialing trust determinations.
- 2 Moderate Tier (MT)** – Investigations conducted to this standard are for positions designated as Non-Sensitive/Moderate-Risk Public Trust and Non-Critical Sensitive/Moderate-Risk Public Trust. For Non-Critical Sensitive positions, this standard of investigation can be used to grant eligibility for access to Confidential and Secret Information, or eligibility for “L” access.
- 3 High Tier (HT)** – Investigations conducted to this standard are for positions designated as Non-Sensitive/High-Risk Public Trust, Critical-Sensitive/High-Risk Public Trust, or Special-Sensitive/High-Risk Public Trust. For Critical-Sensitive or Special-Sensitive positions, this standard of investigation can be used to grant eligibility for access to Top Secret and Sensitive Compartmented Information (SCI), or eligibility for “Q” access.
