CI Awareness and Reporting summarizes the potential threats and collection methods used by Foreign Intelligence Entities (FIE), Potential Espionage Indicators (PIE), warning signs of terrorism, and reporting responsibilities. This update lists the reporting requirements for Anomalous Health Incidents (AHI). An Anomalous Health Incident is when one or more individuals may experience an unexplained sensory event coupled with physical symptoms.
